Acorn Energy Co-op Annual Meeting Notice

**Annual Meeting Set for
Thursday, March 31st, 2016**



The 8th annual meeting of the Acorn Renewable Energy Co-op will be held between **5 and 7 p.m. on Thursday, March 31, 2016 in the lower social space at Two Brothers Tavern, 86 Main Street in Middlebury**, Vermont. The Nominating Committee has prepared a slate of director candidates for the 2016-2017 board of the co-op ([see biographies here](#)).

The meeting will start with a presentation by Acorn Energy Co-op board member Taborri Bruhl of New Haven, entitled, "Here's How We Fix It! Solving the World's Sustainability Problems," that will offer the big picture view of existing technologies that could solve many of these problems, and the lifestyle changes that might result from their wider implementation and use.

The membership will also hear officers' reports, a description of proposed changes to our bylaws necessitated by a need to correct some problems with our original Articles of Incorporation, and any other business that may legally come before the meeting.

A little background on the bylaw changes. Last year, we learned that there were a number of technical issues with our original Articles of Incorporation that needed to be fixed. We authorized the preparation of Articles of Amendment and Restatement to eliminate those issues. In brief, the new Articles contain most of the original information we filed with the Secretary of State back in 2008-2009 with some technical additions/corrections. This in turn has necessitated some technical adjustments to our bylaws to bring the two documents into agreement. Most of these changes are fairly minor or technical, with two exceptions. Section 7.2 - Certificates, has been deleted, since we, like most other consumer co-ops in Vermont, have never sent out certificates of ownership to our members. They're simply not required, and we wanted to eliminate this section to reflect that reality. The second major change is Section 9.3 - Liquidation, which has been deleted and moved to the Articles of Amendment, where our legal counsel says it more properly belongs. Your board of directors has already reviewed and approved the changes to the Articles of Amendment and Restatement, as well as the changes to the bylaws. We recommend approval by our membership.
